Through an innovative and award-winning grocery store styled shopping system, Food Bank customers themselves choose the healthy food they want to take home each visit. The Food Bank supplements the three-day supply of food offered to each customer with other essentials such as toiletries, baby formula, diapers and pet food (as needed). The Food Bank also helps customers make connections to important community resources such as discounted bus fare,

voter registration, and the Seattle Public Library System. It is one
of the busiest food banks in the City of Seattle.

In addition to the walk-in food bank, the Food Bank offers several
programs to provide food to individuals and families in the community
who are unable to come to the Food Bank's physical location. The home
delivery program supports 160 homebound seniors and severely disabled
individuals each week. Teams of volunteers bring these families
customized food boxes every Wednesday. Packs for Kids, which is the
school backpack program, provides 600 children in grades K through 12
from 14 nearby schools with healthy and easy-to-prepare meals, snacks,
and drinks for the weekend when school meals are not available.

The Food Bank operates a rooftop garden called Rooftop Roots. Through
